

NARRATIVE:

On Tuesday March 1st, 2022 Tonya Scott contacted Mitchell County Sheriff's Office to report that a lock had been broken off of a box. Tonya works for Loraine Wind Farm. I, Deputy Jeremiah Witte, drove to 4274 County Road 446 to meet with Tonya. 4274 County Road 446 is north of Loraine and is the main office address for Loraine Wind Farm. I met with Tonya at approximately 11:45 am. Tonya told me that someone had broken off a lock to a junction box and didn't believe that anything had been taken. Tonya contacted BURT, QUINTEN to have him meet me at the location of the junction box.

I drove to North 644 just north of FM 1899. The site was for Turbine Location 69. At this time, there is not a windmill at this location just the pad for the windmill. Just south of this location is a feeder junction box, F7-JCT #7C. There was a master lock on the junction box that had been broken off of the box. There was also some other damage to the front of the box. The approximate damage for the box and lock is \$1,000. The lock appeared to have been hit with a hammer. The lock wasn't cut.

I asked Quinten to open the box so I could look inside of the box. Quinten advised that he believed that unknown person(s) had tried to take the copper wire out of the box but was unable to remove the wire. There was some extra copper wire inside the box that was cut. Less than 2 feet of Copper Wire was removed from the box.

Quinten advised that he was doing his monthly inspection for Loraine Wind Farm. Quinten did tell me that he works for Permian. The theft and damage was done sometime between February 1st and March 1st. The case is under investigation.
