I have experience with the San Antonio community through local nonprofits, as well as periodic engagement with city government. My value is in being connected to several critical needs of the SA Climate Ready advisory committees, and providing a unique perspective from those intersections.</p>
<p>Please provide a description of your professional, educational and community/volunteer experience.</p>	<p>I have 9 years experience as Operations Manager for the Climate Program at the World Resources Institute, a leading global think tank on climate policy, GHG mitigation, urban planning, and environmental equity. My Masters from Columbia University included post-colonial analysis of early 19th century oil and gas industry, and I received a BA in History from Trinity University. My earlier work included volunteer and ultimately leading KRTU 91.7fm, an independent noncommercial radio station, including its ambitious launch of a primary Jazz format, and the complete renovation of its facilities and technology. I am also a Den Leader with BSA Pack 59, sharing my Eagle Scout experience with local youth.</p>
<p>Please share your interest and commitment to racial and economic justice and other social equity issues.</p>	<p>Addressing Climate Change in a serious way requires recognizing that we must simultaneously address in real-time the unavoidable consequence already taking place, and work as hard and fast as possible to mitigate further impacts. Research has shown that those damages will land first and hardest on vulnerable communities who are least responsible and least benefited from our rapid exhaustion of Earth's carbon budget. This is one of several difficult realities of the history of our modern society, but Climate Change also represents a singular opportunity to change course. The depth of systemic change necessary to radically shift GHG emissions in our economy and daily lives allows the possibility of solutions that confront, destabilize, or even remove old biases and inequities. We work on Climate Change because we want to live in a better world - - not just a cooler one. Issues of racial, economic, and gender equity are not separate from the mission of "solving" Climate Change. They are</p>

	<p>essential challenges which by addressing head-on, well-designed Climate policies will achieve lasting change and broader acceptance. A focus on Equity is not just an "ends" - - it is a "means" to fighting the Climate Crisis.</p>
<p>Please explain why you would like to serve on this committee.</p>	<p>Since returning to San Antonio in 2013, I've been looking for opportunities to better assist the city with its sustainability - and in particular Climate - based on my knowledge and connections to cutting-edge global analysis and policy recommendations. I attended AACOG meetings and consulted with city council members on ozone issues, cheered at the City's endorsement of the Paris Agreement, advocated the Office of Sustainability on GHG inventories, and participated in on-line and in-person feedback to the SA Climate Ready plan. I continue to be impressed by the seriousness with which San Antonio is discussing Climate issues, and I feel it is a unique opportunity to drive real progress on a topic for which I have both knowledge and passion - - but have, until now, largely relied on others to carry forward. In whatever way I can, I want to use the coincidence of my knowledge, background, contacts, and location to help San Antonio set the bar for what a Climate-Smart 21st century city can be.</p>
